

















CK Schools: 2020-21 Learning Model Comparison

	Remote + In Person (<i>Hybrid Model</i>)	All Online - "CKSD Virtual Academy" (<i>Pearson Connexus</i>)	K-8 CKSD Homeschool
Grade Levels 	K-12	K-12	K-8
Schedule 	This model will begin as fully remote, based on current guidance from state and local health authorities. Upon approval to reopen, schools would operate on a rotating AA/BB schedule. Students would attend in person two days each week and learn remotely three days each week. About half of each school population would attend on each in-person day.	Students work independently and sequentially through the assigned courses on their own schedule. Students are guided by both system- and teacher-generated feedback and grading.	Full-time students are required to spend at least 27.75 hours a week in learning activities in grades 1-8 and 10 hours in kindergarten.
Live Instruction 	Upon approval to reopen schools, students would receive at least two full days of in-person, live instruction each week. More in-person instruction is possible based on community health conditions and state/local guidance.	No live instruction	No live instruction. Enrichment classes may be possible based on community health conditions and if OSPI guidance changes.
Online Learning 	At least three days of remote learning each week. More or fewer remote learning days are possible based on the number of in-person days. In case of a school or district closure, students would temporarily move to all-remote instruction with Google Classroom, and no in-person instruction. In-person instruction would resume upon clearance from health authorities.	100% online through Pearson Connexus (PC), an online curriculum platform.	Families check out textbooks and other materials. These are the same materials used in our other CK schools. Optional, supplemental online resources are available at each family's discretion.

Role of CKSD Teacher 	<p>A CKSD teacher from the student's school will provide in-person and remote instruction. Health Protocols 	On in-person days, staff will instruct students on health and safety protocols, and ensure they are following state health guidelines. Highly Capable 	Additional services provided to challenge highly capable students, including higher-level learning materials, assignment options and/or special projects in general or self-contained classrooms. At secondary, this could include Honors and dual credit college courses through the AP and CiHS programs for 9-12 students.	K–12 students provided with advanced assignments and reading selections that foster higher order thinking skills for enrichment within their grade band. No AP, CiHS or Honors classes offered.	Included in the Written Student Learning Plan.
Technology Needs 	A Chromebook is provided by the district for both in-person and remote learning. Internet access is needed for remote learning.	A Chromebook is provided by the district. Internet access is needed for online learning.	A computer and internet access is not required, but is highly recommended, as there are many online opportunities available to students.
Social/Emotional Support 	Onsite and distant/virtual social and emotional support for students is provided by teachers and counselors.	District-level resources are available for students through CKSD websites.	District-level resources are available for students through CKSD websites.
ELD Needs 	Additional services provided to meet the needs of ELD students and families.	ELD instruction and assessment available.	Determined by the Written Student Learning Plan.
